Greetings,

We would like to invite you to participate in the Monmouth Fair Market Place on Sunday, June 16. In case you haven't heard – we have changed our fair dates to the 2<sup>nd</sup> weekend in June!

The area is an opportunity for local artisans and producers to expose fairgoers to their products and services. We have an unlimited number of outdoor 10 x 10 foot spaces at \$25 for the day (you need to provide your own tent/cover). The hours for the Market Place will be 10 AM to 4 PM – on what we have designated “Family Day”. You will receive 2 day passes for the day.

You will need to provide all of the displays, tables, and chairs for your booth - similar to a farmer's market. You will have easy access to the area (drop off and carrying of supplies no more than 50 feet) for set up before 10 AM. We must maintain the state fair regulations of **no motor vehicles on the grounds during open hours**. The fair is open until 5 PM on Sunday. Until then you cannot moved vehicles through the fairgrounds, only on the outside circular access road. There is no electricity or water in the area. Potable water, bathrooms, and hand washing facilities are nearby.
